		 The committee discussed providing a full gaps analysis report to the CoC for review and direction, in which then they could provide outcomes to the Independent Review Panel. The committee reviewed 2017 subpopulation PIT data including veterans, chronically homeless, youth and families, elderly, single adults, and people experiencing drug or alcohol addictions, mental illness, and domestic violence. Additional discussion took place in regards to grants available for youth homelessness such as HUD's Youth Homelessness Demonstration Program (YHDP) and youth funding provided through Substance Abuse and Mental Health Services Administration (SAMHSA).
