Notes:

- (1) The reference to "City/Area" is a table value based on the declared zip code and may not be the recorded city or area in the database. The source of the "City/Area" column does not include all of the unincorporated areas.
- (2) POBox column codes: (P) from the postoffice to signify that a zipcode is for PO Boxes only, and (I) to signify a zipcode that is serviced by multiple counties.
- (3) Since CalWORKs Temporary Assistance (CWTA) recipients also receive Medi-Cal benefits, the total for Medi-Cal is the sum of both CalWORKs and Medi-Cal only. It does not include Foster Care, CAPI or Refugee cases, all of which receive Medi-Cal benefits.
- (4) Non-assistance CalFresh recipients belong to a CalFresh household for which there is no active CalWORKs case.
- (5) Public Assistance CalFresh recipients belong to a CalFresh household for which there is an active CalWORKs case.
- (6) Transitional CalFresh recipients belong to a CalFresh household transitioning out of CalWORKs off aid and into the workforce.
- (7) The category "Other/Out of County" refers both to cases with zip codes for an out of county address at the time this data was processed and erroneous zip code entries which have no apparent valid reference.



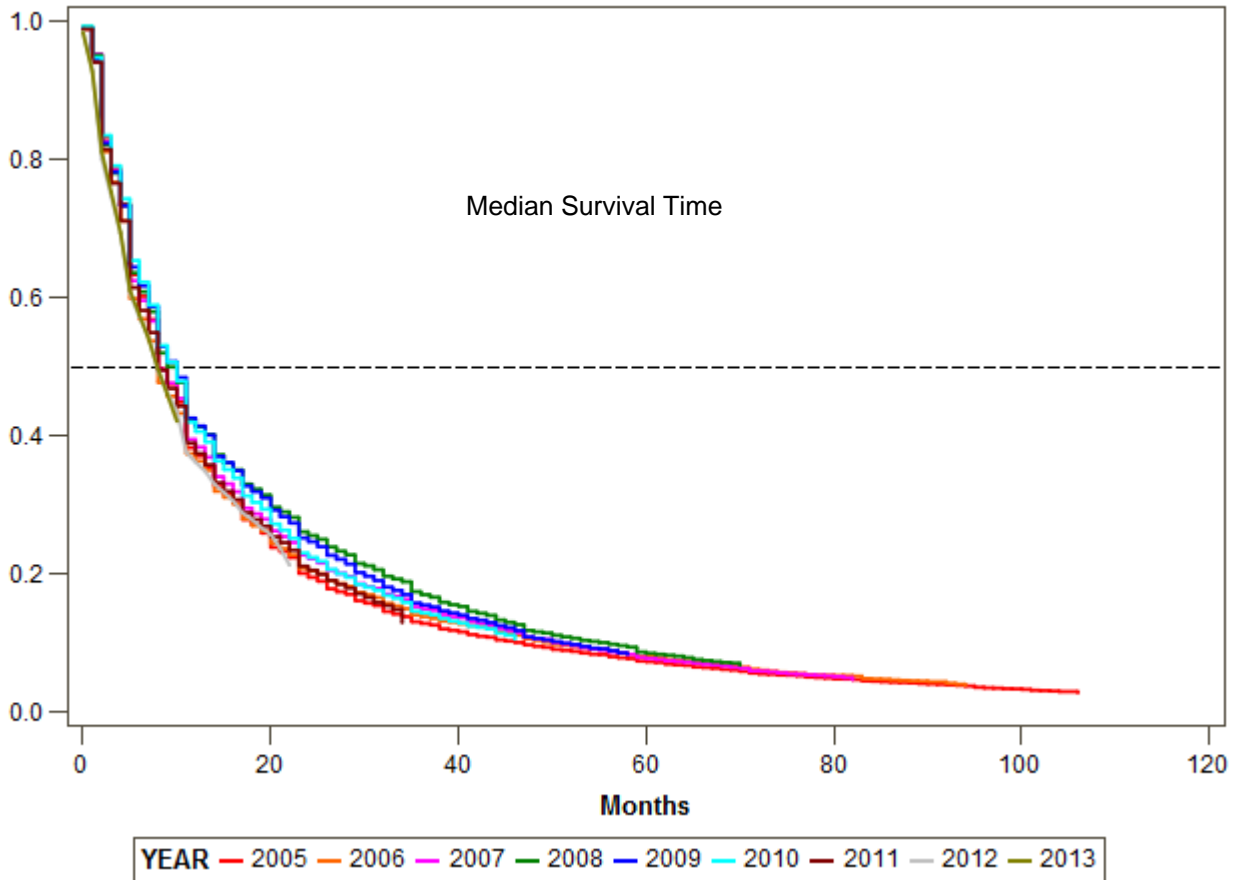


Time on Aid: CalWORKs & CalFresh

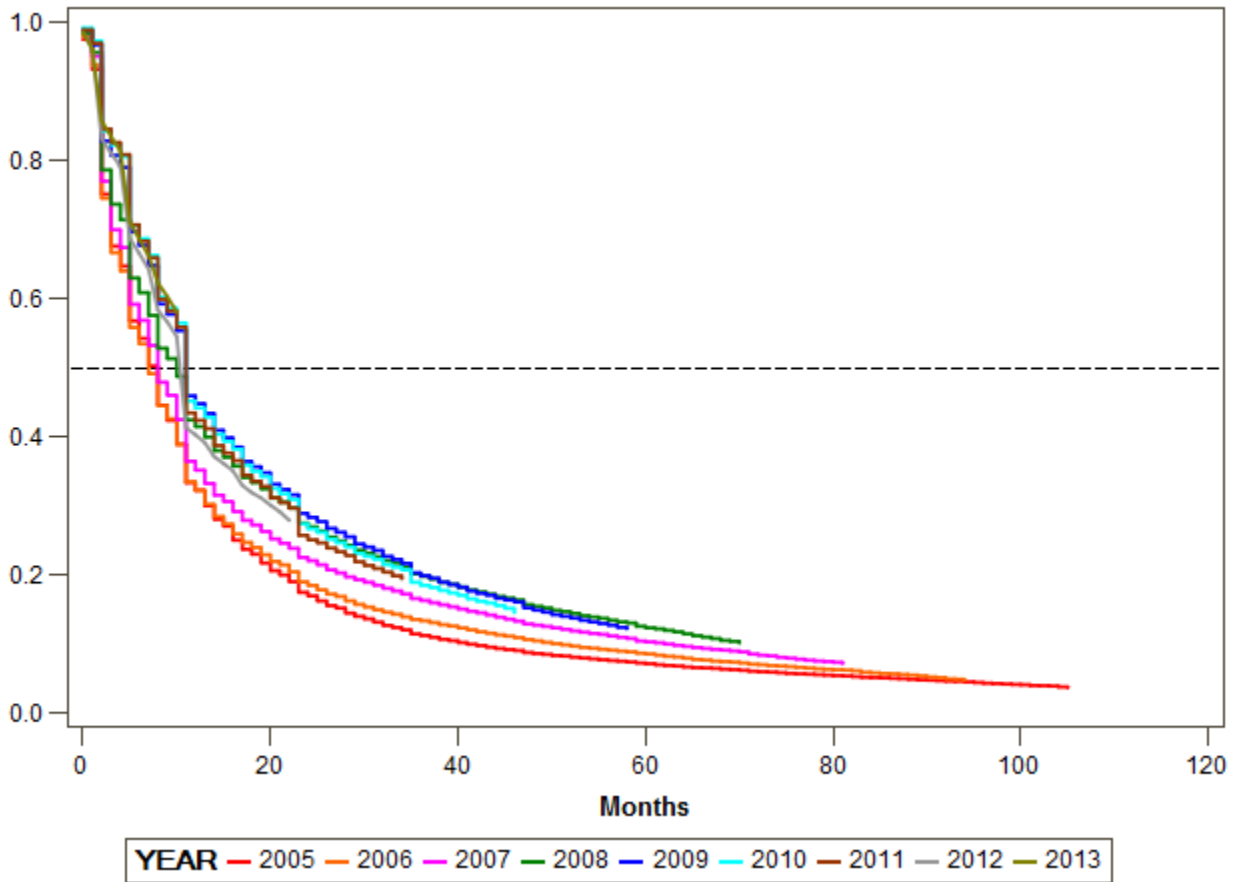
