

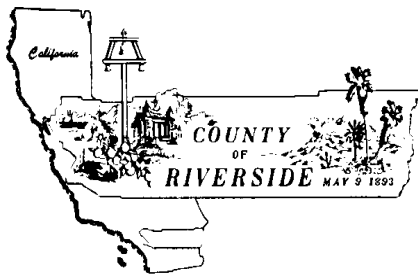

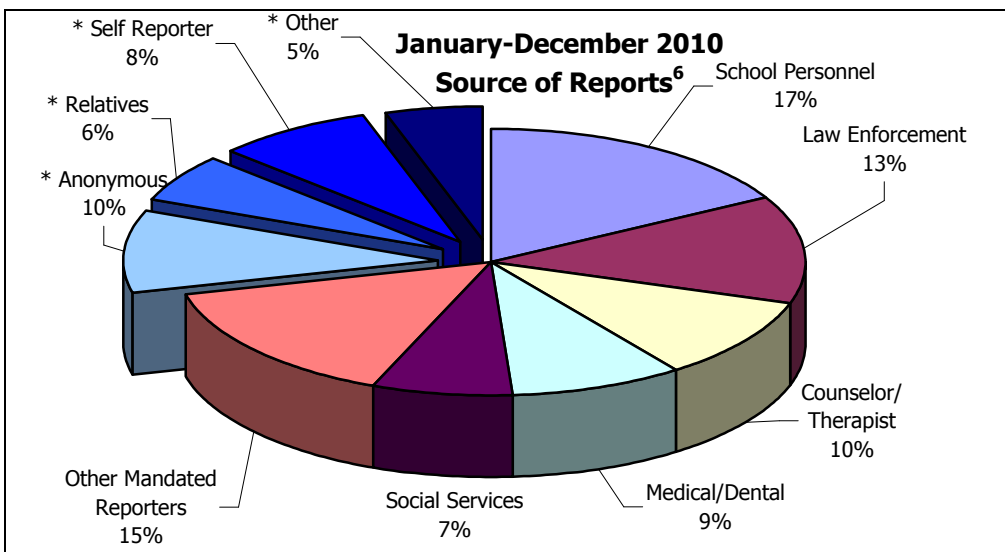
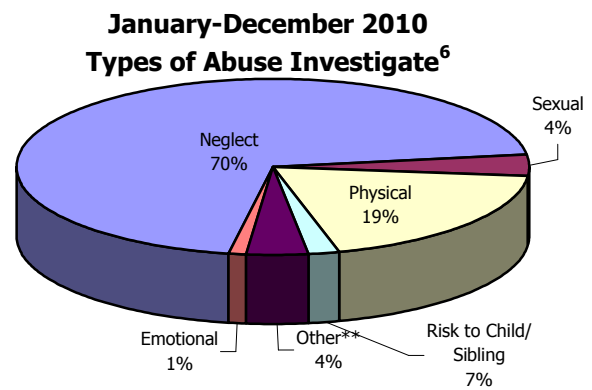

**2010 HOTLINE CALLS**

Telephone calls to CPS Hotline include requests for information and reports of abuse:<sup>5</sup> **58,528**  
 41% of all calls (24,125) are reports of suspected abuse and/or neglect.

Of all referrals received, 81% resulted in CPS investigation:	19,643	39,202
Of all referrals investigated, 23% were found to be true:	4,519	8,364
Of all referrals investigated, 10% resulted in an open case:	1,867	3,581
Of all referrals investigated, 8% resulted in child removal:	1,508	2,762

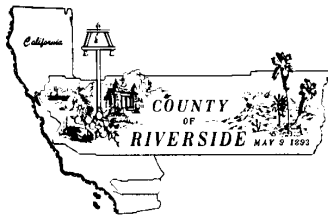

## 2010 CHILDREN IN OUT-OF-HOME CARE [Point-in-Time]<sup>7</sup>

Figure 1 - Children in Care by Placement Types<sup>8</sup>

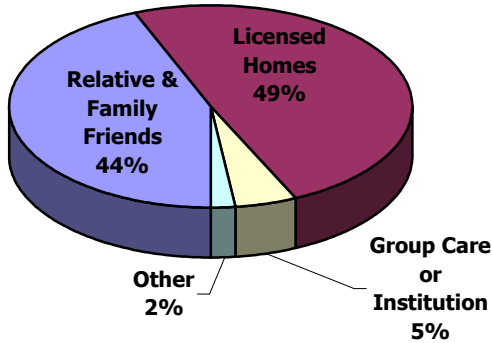


Figure 3 - Children in Care by Age Group<sup>7</sup>

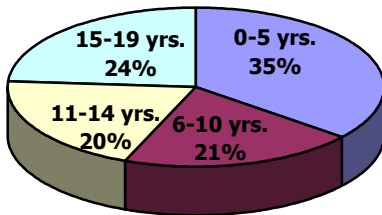


Figure 5 - Children in Care by Primary Ethnicity<sup>7</sup>

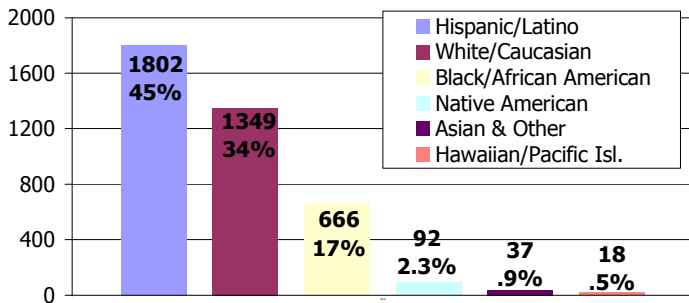


Figure 2 - Children in Care by Age & Home Type<sup>7</sup>

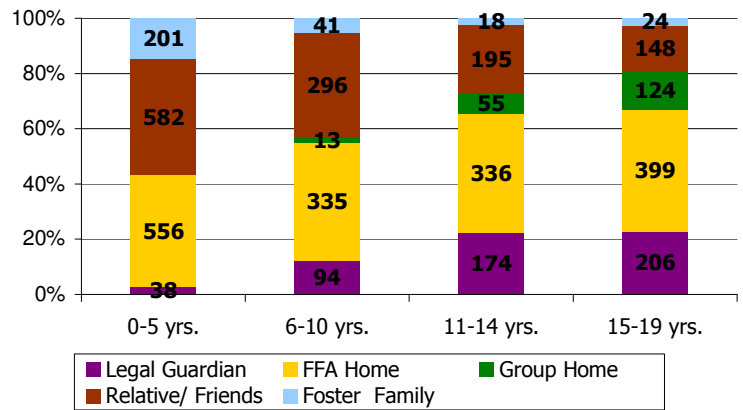
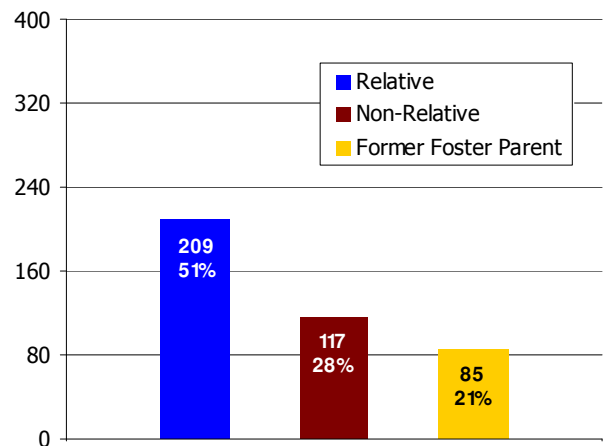


Figure 4 - Total of 411 Children Adopted in 2010<sup>9</sup>
